Background:

- 1. IIT Mandi iHub and HCi Foundation is a Technology Innovation Hub (TIH of IIT Mandi). It is focused on Human-Computer Interaction (HCi). It is set up by the Indian Institute of Technology (IIT) Mandi under India's National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS). The vision of IIT Mandi iHub and HCi Foundation is to be internationally recognised Hub that nurtures HCi research enables technology translation for industry and skill development.
- 2. IIT Mandi iHub and HCi Foundation is operating from IIT Mandi, North campus, located in Mandi, Himachal Pradesh, 175005.
- 3. IIT Mandi iHub and HCi Foundation invites expression of interest [EOI] for renting of property/building for hostel accommodation for students, staff and training activities.

Requirements of IIT Mandi iHub and HCi Foundation:

- 1. IIT Mandi iHub and HCi foundation has an immediate requirement of accommodation for 150 students enrolled in skill development courses, as well as appointed staff, interns and for training activities along with provision of accommodation of 30 more students in the subsequent year along with attached toilet-cum-bathroom facility located in Salgi, Mandi Himachal Pradesh on entirely temporary basis initially for a period of one year which may be further extendable on year-to-year basis up to maximum period of one year on monthly rent basis, inclusive of all GST.
- 2. The building should have minimum 30 Rooms along with common/attached toilet-cumbathroom facility. The immediate requirement is of accommodation for 150 students. In the subsequent years accommodation for total of 180 students would be required.
- 3. The required building for accommodation should be within the area of 10 km from IIT Mandi iHub and HCi Foundation office.
- 4. The hostel building is required to accommodate minimum 2 students per room.
- 5. The accommodation should be neat and clean having well-ventilated and airy rooms in habitable condition with hygienic environment.
- 6. Electricity and potable water for drinking and bathing, must be available round the clock in the accommodation throughout the year.
- 7. All the sanitary and water supply installation connections must be provided in the facility.
- 8. Electrical installation and fittings like power plugs, switches, charging points, tube lights, fans etc. must be in place.
- 9. Geyser or hot water facility in bathroom should be present.
- 10. All necessary amenities shall be provided in rooms. Necessary modifications required to be carried out in the rooms / building for improving the utility shall be done by the owner.

Terms and conditions:

- 1. Selected party will be required to execute a lease agreement containing detailed terms & conditions with **IIT Mandi iHub and HCi Foundation**, in accordance with the provisions of the law applicable. The agreement shall be signed for an initial period of one year, depending upon requirement, may be extended further on year-to-year basis up to maximum period of one year on mutually agreed terms and conditions on the satisfactory performance.
- 2. The agreement for renting of buildings/accommodation shall come into force immediately after it is executed and shall remain in force for the period agreed upon.
- 3. Possession of the accommodation will be handed over to IIT Mandi iHub and HCi Foundation within 30 days from the award of the order. The premises should be ready for occupation in all respect of facilities i.e., water, drainage, electrical fittings, etc. Rent shall be payable from the date of possession of the property.
- 4. **Payment terms:** IIT Mandi iHub and HCi Foundation shall pay monthly rent all-inclusive of GST. Payment of rent shall be made by RTGS/NEFT/ month wise on submission of bill after deducting the applicable taxes, etc.
- 5. **Utilities and services:** The landlord shall be responsible for regular maintenance and repairs, including plumbing, electrical, and structural maintenance.
- The electricity and water supply lines / connections shall be provided by the owner at his own cost and expenses.
- Regular RO water and electricity must be available and necessary standby arrangements would be provided for water & electricity.
- Building offered must be free from all, charges, claims and legal disputes etc. The landlord/owner is required to furnish an undertaking /affidavit dully attested by the competent authority swearing therein that the owner is not blacklisted / disqualified at any time by any government /authority from participating in the bidding process or has not been disqualified by any competent authority.
- The building should have been properly constructed according to the sanctioned plan of competent authority as per the requirements of town and country planning department / Municipal Corporation, or any other concern authority, and as per the approved safety plans/norms.
 - The IIT Mandi iHub and HCi Foundation, Mandi shall not be liable or responsible for any damage caused to the premises during the term of the rent deed as result from any fire, earthquake, storm, war, civil disturbance, riots, or any natural calamity or act of God which is beyond the control of the IIT Mandi iHub and HCi Foundation.
 - All property tax, all municipality tax, local taxes will be included in the rent.
 - The responsibility for payment of all taxes such as property tax, income tax, water tax etc. in connection with the property offered shall be of the agency/owner and updated copies of all tax receipts should be attached with the applications.
 - 6. **Use of property:** The premises should be a separate building for exclusive use of IIT Mandi iHub and HCi Foundation. The premises will be used for hostel accommodation for students and

carrying out training activities. No commercial activity other than the accommodation will be carried out on the leased premises.

- 7. **Penalty clause:** The IIT Mandi iHub and HCi Foundation reserves the right to check and inspect the hostel premises on regular basis by the authorized officials / expert committee. In case of any deficiency or deviation in services from the clauses mentioned in the EOI/agreement may impose penalty on the service provider / building owner for those deficient services. The penalty will be decided by the expert committee of the IIT Mandi iHub and HCi Foundation and the decision will be binding on the service provider / building owner.
- 8. **Maintenance and repairs:** The owner will be responsible for major repairs and maintenance, including structural repairs and replacements.
- 9. The tenant will be responsible for minor maintenance and repairs, including cleaning and replacing light bulbs.
- 10. Service maintenance charge shall be inclusive in the rent. IIT Mandi iHub and HCi Foundation, will not pay any maintenance charge.
- 11. **Safety and security:** Clearance safety certificate, structure safety certificate from building safety department in case of commercial building is essentially required.
- 12. Proper fire safety arrangements are mandatory in the premises to be installed at the time of agreement.
- 13. **Insurance:** The owner will maintain building insurance to cover damage to the premises. Should cover natural calamities like earthquakes, landslides etc.
- 14. **Termination:** The agreement may be terminated by giving three months' notice by IIT Mandi iHub and HCi Foundation. However, during such notice period the building/accommodation along with all ongoing facilities shall remain in the possession of IIT Mandi iHub and HCi Foundation. The tenancy of IIT Mandi iHub and HCi Foundation shall be governed by the prevailing law as applicable to the parties. The owner shall not withhold any facility / necessary amenities provided in the building.
- 15. In case of unsatisfactory maintenance of the building by the agency, IIT Mandi iHub and HCi Foundation reserves its right to terminate the contract by giving one month's notice or get the repairs done on its own and deduct the amount spent by it from the rent payable. However, if the agency gets the repairs done to the satisfaction of IIT Mandi iHub and HCi Foundation within the notice period of one month, IIT Mandi iHub and HCi Foundation may at its sole discretion withdraw the notice with or without penalty.
- 16. The decision of the IIT Mandi iHub and HCi Foundation will be final in case of any dispute arising in the implementation of the terms of the contract.
- 17. **Force Majeure:** If at any time, during the continuance of this contract, the performance in whole or in part by either party, of any obligation under this contract, shall be prevented or delayed by force majeure situation, the agency shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the contract is the result of an event of force majeure. For purposes of this clause, "Force Majeure" means an event beyond the control of the agency/ firm and not involving the agency/ firm's fault or negligence and not foreseeable. Such

events may include, but are not limited to, acts of the IIT Mandi iHub and HCi Foundation either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes. Neither party shall be due to reason of such event be entitled to terminate this contract nor shall either party have any such claim for damages against the other in respect of such non-performance or delay in performance.

18. In case of any dispute arising out of the terms & conditions of contract or assignment, the matter shall be referred to the Sole Arbitrator to be appointed by the CEO, IIT Mandi iHub and HCi Foundation and the award of the Sole Arbitrator will be binding on both the parties. In the event of death, refusal, neglect, inability or incapability of the person so appointed to act as an arbitrator the CEO, IIT Mandi iHub and HCi Foundation may appoint a new arbitrator. The venue of arbitration shall be the respective office of the sole arbitrator or a place suitable to IIT Mandi iHub and HCi Foundation, Mandi unless otherwise specified in the arbitral award the cost of such arbitration shall be borne by the landlord and there will be no objection to this effect by any of the parties. Further, any legal dispute arising out of any breach of contract shall be settled in the court of competent jurisdiction located within the local limits of Mand, Himachal Pradesh.

Preparation and submission of application

The applicants are advised to go through the EOI documents in detail and understand the requirement and terms & conditions specified therein before submitting the tender.

- 1. Both the bids **(Technical and Financial)** duly signed by the owner, or his/her authorised signatory should be submitted in two separate sealed envelopes as described below:

- 3. Following documents to be submitted along with the technical bid:

- Ownership document of the building or agreement copy if the premise is on lease.
- Structural safety certificate from competent authority (both in case it is a commercial building).

- All other requisite documents in support of bid as per terms & conditions given in EOI.
- **4.** The bidder shall offer room rent inclusive of all charges i.e., water supply charges, maintenance, service charges, security services and taxes, etc. The IIT Mandi iHub and HCi Foundation shall not pay any over and above rent of the building.
- **5.** The technical bid should be accompanied by a copy of this EOI document with each page duly signed by the authorized signatory of the applicants, who has signed the application, as token of having read, understood and complied with EOI, the terms & conditions contained herein. Applications not accompanied by a duly signed copy of the EOI document will not be considered.
- **6.** All the requisite information should be filled up in prescribed form and the filled-up application form, relevant information and required document should be clearly readable and all the pages of the document should be signed by authorized signatory.
- 7. Applications must reach on or before the closing time and date as indicated in the beginning of this document. Any application received after closing date/time shall not be considered. Applications received by REGISTERED POST/SPEED POST/COURIER is accepted. Applications received by any other mode like FAX/E-MAIL etc. will not be accepted. The IIT Mandi iHub and HCi Foundation will not be responsible for any postal delay.
- **8.** The IIT Mandi iHub and HCi Foundation shall not be responsible for misplacement, loosing or premature opening of the outer envelope if not sealed and/or marked as stipulated. This may be reason for rejection of the bid. If the financial proposal is not submitted in a separate sealed envelope duly marked as indicated above, this will constitute grounds for declaring the proposal non- responsive.
- **9. Bid validity:** The bid shall remain valid for a period of **90 days** from the last date of submission of proposal. In case the applicant withdraws, modifies or changes his offer during the validity period, application is liable to be rejected without assigning any reason thereof and the applicant may be barred for 3 years to participate against any tender / EOI / RFQ of IIT Mandi iHub and HCi Foundation.
- 10. Any changes / corrigendum/extension of closing/ opening dates in respect of this EOI shall be issued through IIT Mandi iHub and HCi Foundation website only and no press notification will be issued in this regard. Applicants are therefore requested to regularly visit IIT Mandi iHub and HCi Foundation website for updates.
