Description:

Call for Innovation (CfI) is a program focused on addressing real-life problems with the intervention of HCi. This program is designed to provide innovators, researchers, and technology enthusiasts who are passionate about translating their ideas into productized solutions for industry adoption. The applicant may be a startup or from academia, or from the mainstream industry in the area of HCi. HCi is the confluence of Computer Science, Industrial Design, and Cognitive Science.

Eligibility Criteria:

• **Common:** Start-ups with an innovative HCi-based idea/solution.

For *CPS Prayas:

• Anyone applying for CPS - PRAYAS must be an Indian citizen and possess government-approved nationality proof, such as a valid passport or voter ID. The applicant should be at least 18 years old at the time of application.

For CPS Seed Support System (SSS) and CPS Dedicated Innovation Accelerator (DIAL):

- Start-up must be registered private company.
- The startup must be an Indian entity. This support is not intended for Indian subsidiaries
 of multinational or foreign companies. Individuals with Overseas Citizen of India (OCI) or
 Person of Indian Origin (PIO) status will be regarded as Indian citizens under this scheme.
- Indian promoters should hold a minimum of 51% shareholding in the startup.

- Assistive Technologies (including **BCi): Access & technology usage, regardless of their abilities
- Device-Led Technologies: Usage of device features and capabilities to enhance users' intuitive interaction
