

Background:

- 1. IIT Mandi iHub and HCi Foundation is a Technology Innovation Hub (TIH of IIT Mandi). It is focused on Human-Computer Interaction (HCi). It is set up by the Indian Institute of Technology (IIT) Mandi under India's National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS). The vision of IIT Mandi iHub and HCi Foundation is to be an internationally recognised Hub that nurtures HCi research and enables technology translation for industry and skill development.
- 2. IIT Mandi iHub and HCi Foundation is operating from IIT Mandi, North campus, located in Mandi, Himachal Pradesh, 175005.
- 3. IIT Mandi iHub and HCi Foundation invites expression of interest [EOI] for DGCA-registered Remote Pilot Training Organizations (RPTOs) for providing Remote Pilot Certification (RPC) to students.

Requirements of IIT Mandi iHub and HCi Foundation:

- 1. **Location:** The training facility must be located in regions of Himachal Pradesh, Punjab, Haryana, and Delhi.
- 2. **Training quality:** The training partner must ensure high-quality training with expert instructors and a comprehensive curriculum, providing all necessary training material, equipment, and resources for effective learning. Ensuring the training follows DGCA guidelines and results in DGCA-approved RPC certification. Arranging practical and theoretical sessions aligned with DGCA mandates.
- 3. **DGCA approval:** The applicant must be a Remote Pilot Training Organization (RPTO) approved by the Directorate General of Civil Aviation (DGCA), Government of India.
- 4. **Prior experience in RPC:** The RPTO must have prior experience in delivering Remote Pilot Certificate (RPC) training, demonstrating a proven track record of successful training programs.
- 5. **Training capacity:** The RPTO must have adequate infrastructure to conduct training for minimum 10 or more students per batch as per DGCA guidelines, ensuring sufficient resources and equipment for effective learning.
- 6. **Accessibility:** The location should be at least 15-25 km from the nearest town/city, with proper transportation facilities to ensure students' convenience.
 - 7. **Accommodation:** The RPTO is required to provide accommodation and food for the students throughout the training period. Proposals should include detailed cost estimates for accommodation and food per student. The stay arrangements must ensure a safe and comfortable environment conducive to learning.
 - 8. **Training category:** We require training under the small **drone category.**

Evaluation Process:

Proposals will be evaluated based on:

- 1. Compliance with DGCA standards and eligibility criteria.
- 2. Training capacity and infrastructure.
- 3. Financial feasibility and transparency.

4. Experience in conducting similar training programs.

Terms & conditions:

- 1. The training must comply with DGCA guidelines and lead to the issuance of DGCA-approved RPC certification.
- 2. RPTOs must ensure the safety and well-being of students during the training period.
- 3. IIT Mandi iHub reserves the right to verify the infrastructure and facilities before awarding the contract.
- 4. Payment terms will be mutually agreed upon after selection.
- 5. The RPTO must provide reports on training completion and certification for each student.
- 6. The applicant must be a DGCA-approved RPTO.
- 7. The RPTO must have prior experience in delivering RPC.
- 8. The decision of the IIT Mandi iHub and HCi Foundation will be final in case of any dispute arising in the implementation of the terms of the contract.
- 9. Contract Termination and Penalty Clause: If the RPTO fails to provide the agreed services or does not meet the required standards, IIT Mandi iHub reserves the right to terminate the contract with one-month prior notice.
- 10. A penalty of up to 10% of the total contract value may be imposed for non-performance, delays, or failure to meet training quality standards.
- 11. Persistent non-compliance or failure to rectify issues within the notice period will result in immediate termination of the contract.

Preparation and submission of application

The applicants are advised to go through the EOI documents in detail and understand the requirement and terms & conditions specified therein before submitting the tender.

Both the bids **(Technical and Financial)** duly signed by the authorised signatory should be submitted in two separate sealed envelopes as described below:

- 5. The IIT Mandi iHub and HCi Foundation shall not be responsible for misplacement, loosing or premature opening of the outer envelope if not sealed and/or marked as stipulated. This may be reason for rejection of the bid. If the financial proposal is not submitted in a separate sealed envelope duly marked as indicated above, this will constitute grounds for declaring the proposal non-responsive.
- 6. **Bid validity:** The bid shall remain valid for a period of **90 days** from the last date of submission of proposal. In case the applicant withdraws, modifies or changes his offer during the validity period, application is liable to be rejected without assigning any reason thereof and the applicant may be barred for 3 years to participate against any tender / EOI / RFQ of IIT Mandi iHub and HCi Foundation.




